#### **Scope and Content**

The greater part of Jose Mariano Bonilla's papers were lost in a storm. The few preserved here were presented to The Bancroft Library in 1878 by his widow, Doña Dolores García Bonilla. Also included are a few papers of Manuel Larios. A chronological calendar and an index are appended.

#### **Biographical Sketch**

Bonilla, born in Mexico City in 1807, came to California in 1834 with the Hijar and Padres colony. He held various responsible public offices in San Luis Obispo — alcalde, judge, and district attorney. He died in 1878.

Passport, signed as governor of Alta California, Feb. 1, 1840, for Juan Higuera to go to the Sandwich Islands. Also signed by Manuel Jimeno. Doc. 44

Bonilla, José Mariano, 1807-1878

Document, written as Juez, San Luis Obispo, Dec. 1, 1842, granting to Odon, an Indian, a house and small garden. Doc. 10-11

Draft of statement made before Juan Antonio Vallejo for power of attorney from José María Castañares to Francisco Castañares. Unsigned, Dec. 7, 1843. Written by Bonilla? Doc. 14-15

Jimeno Casarín, José Joaquín, 1804-1856

Certificate, Jan. 22, 1844, stating that José María Aguile had worked for the Mission of Santa Inés in 1841, and went to San Luis Obispo where he died, even though no record was made in the Book of Burials. Doc. 16
